- a) Having given a minimum of 30 coaching hours (for CCC®) /60 coaching hours (for ECC®) / 90 coaching hours (for CCMC®) to paying clients in the last two-year period.
- b) Having attended minimum 3 CCA mentor coach sessions in the last two-year period of time.
- c) Be a registered member of an acknowledged coach organization (ICF or other).

Application for renewal must be submitted in an email, providing the following details:

- a) Date when CC® coach diploma was obtained.
- b) Date when current CCA credential was obtained.
- c) Current CCA credential (CCC®, ECC®, CCMC®)
- d) Desired CCA credential (CCC®, ECC®, CCMC®)



- e) Proof of 30 coaching hours (for CCC®) /60 coaching hours (for ECC®) / 90 coaching hours given (for CCMC®) to paying clients in the last two-year period submitted in a CC® logbook table (downloadable on CCA student area).
- f) Proof of minimum 3 CCA mentor coach sessions in the last two-year period submitted in a CC® logbook table (downloadable on CCA student area), mentioning the name of the mentor coach and the date of the session.
- g) Name of an acknowledged coach organization of which you are a member and your membership number.
- h) Proof of payment in case you request an upgrade of your current credential. If you simply renew your existing credential, no fee needs to be paid.

7. I agree that CCA may change or modify the rules governing Credentialing at any time and has the power to revoke any individual credential for violation of the CCA Standards of CC®.

8. I give permission for CCA to verify my experience and documentation. I understand that CCA will keep all information confidential.
